## Legal Services of Greater Miami Presented Equal Justice Judicial Leadership Awards to Three Exemplary Judges: Judge Altonaga, Judge Hanzman, and Judge Sayfie

Miami, FL – May 20, 2022 - Legal Services of Greater Miami (Legal Services), the largest provider of broad-based civil legal services for low-income residents in Miami-Dade and Monroe Counties, honored distinguished Equal Justice Judicial Leaders of the South Florida Community at this year's 13th Annual Heart of Giving Celebration and Judicial Reception. The charismatic Louis Aguirre, WPLG Local 10 News Anchor, served as Master of Ceremonies of one spectacular evening of celebration and community held on May 12, 2022, at the Paradise Plaza Event Space in the heart of the Design District.

These three exemplary leaders were presented with the **2022 Equal Justice Judicial Leadership Awards for their outstanding contributions to the pursuit of justice**:

- The Honorable Michael A. Hanzman, Circuit Judge of the Eleventh Judicial Circuit Court

This year, Legal Services also presented the **2022 Equal Justice Public Service Awards** to **Chairman Jose "Pepe" Diaz** and **Commissioner Sally Heyman** of the Miami-Dade County Commission, both leaders who recognize the importance of access to justice and how critical it is to ensure their constituents can enforce their legal rights.

The program concluded with **remarks from Community Services Officer Morris Copeland**. On behalf of Miami-Dade County Mayor Daniella Levine Cava, Chief Copeland presented each honoree with a certificate of commendation in appreciation of their service.

"The Heart of Giving has always been an opportunity to celebrate and honor leaders in our community, who share a common vision and passion for access to justice, and this year is no exception. We are grateful to all our honorees for their significant contributions of service and leadership," said Monica Vigues-Pitan, Executive Director of Legal Services of Greater Miami.
